# Information for Vending at PRANIC Festival

PRANIC 2015 is an intimate mastermind gathering – with a \*very\* limited number of spaces for vendors. We are currently accepting applications for businesses that are in alignment with the spirit of our unique event – e.g. conscious/eco-minded businesses, selfempowerment healing tools, wellness services, sustainable fashion, yoga gear, etc.

Audience and Estimated Attendance: 100 participants

PRANIC 2015 will be held at beautiful Harmonia in Sausalito, California. This space is the former home of the iconic "Plant Recording Studio" where legendary artists such as Fleetwood Mac, Carlos Santana, Bob Marley and Stevie Wonder recorded their albums. We are thrilled to host our inaugural event in this historic location.

Our cozy gathering will take place in a 1500 sq. ft. newly renovated event space / yoga studio. Vendor tables are placed along the back and sides of the space. There will be no separate expo area. Due to the intimate layout of the event space, we ask you to be mindful of noise. Vendors are warmly invited to participate in the Inspirational Talks & Experiential workshops.

### PRANIC 2015 Vendor Package includes:

- One table (approx. 6ft x 2.5ft) along the back or side of main event space to display your product/service.
- Intimate interactions with all event attendees.
- Includes entry pass for 2 total people staffing your table
- FULL access to all 3-days of talks & workshops (an \$888 value!)

#### Cost: \$333 base fee for vending at all 3 days of the festival. Plus 10% of your sales back to the festival, due by Tuesday, August 17.
